Sharing Joy and Hope in the Community

When considering matters of exclusion, it is important for all the school community to reflect, considering our vision statement, 'Sharing joy and hope in the community'; along with the school values: Respect, Compassion, Friendship, Service and Endurance. Through this we will ensure we are guided into good decisions to support all those in the St John's community.

This code sets out the expectations **on** and commitment required from those serving on the Governing Board at St John's Church of England Primary School in order for it to properly carry out its work within the school. This code, once approved by the Governing Board, will apply to all those associated with governance within our setting, and will be revisited and signed annually.

The Governing Board has the following core strategic functions:

Establishing the strategic direction:

- Setting and ensuring clarity of vision, values, and objectives for the school
- Agreeing the school development strategy with priorities and targets
- Meeting statutory duties

Ensuring accountability:

- Appointing the Headteacher
- Monitoring the educational performance of the school and progress towards agreed targets
- Headteacher Performance Management
- Engaging with all stakeholders
- Contributing to school self-evaluation

Overseeing financial performance:

- Setting the budget
- Monitoring spending against the budget
- Ensuring money is well spent and value for money is obtained
- Ensuring risks to the organisation are managed

Governors agree to the following:

Role & Responsibilities

- I understand the purpose of the Governing Board and the role of the Headteacher.
- I accept that I have no legal authority to act individually, except when the Governing Board has given me delegated authority to do so, and therefore I will only speak on behalf of the Governing Board when specifically authorised to do so.
- I accept collective responsibility for all decisions made by the Governing Board or its delegated agents. This means that I will not speak against decisions outside of meetings.
- When formally speaking or writing in our governing role we will ensure our comments reflect current organisational policy even if they might be different to my personal views.
- I have a duty to act fairly and without prejudice, and insofar as I have responsibility for staff, I will fulfil all that is expected of a good employer.
- I will encourage open governance and will act appropriately.
- I will consider and be mindful of how board decisions may affect the community and other schools.
- My actions and those of my immediate family within the school and the local community will reflect the ethos and reputation of the school.
- I will follow the procedures established by the Governing Board as set out in the Complaints Policy and Procedure.
- I will accept and respect the difference in roles between the Governing Board and staff, ensuring that we work collectively for the benefit of the school.
- I will respect the role of the Headteacher and his responsibility for the day-to-day management of the school, and avoid any actions that might undermine such arrangements, recognising my strategic rather than operational role.
- I agree to adhere to the rules, policies and procedures of the Governing Board as set out in relevant governance documents and law.
- When communicating in a private capacity (including on social media) I will be mindful of and strive to uphold the reputation of the school. There is an expectation that immediate family adhere to the same standards in terms of protecting the reputation of the school.
- I will uphold the Christian vision and values of the school.

Commitment

- I acknowledge that accepting a governance role involves the commitment of significant amounts of time and energy.
- I will involve myself actively in the work of the Governing Board and accept my fair share of responsibilities.

- I will make every effort to attend all meetings and where I cannot attend explain in advance why I am unable to do so.
- I will familiarise myself with the school and respond to opportunities to involve myself in school activities.
- I will visit the school (all visits arranged in advance) in line with any framework established by the Governing Board.
- when visiting the school in a personal capacity (i.e. as a parent or carer), I will maintain my underlying responsibility as a Governor.
- I will be aware of my individual needs for induction, training and development, and will undertake regular (termly) relevant training.
- I accept that in the interests of open governance, my full names, date of appointment, terms of office, role on the Governing Board, attendance records, relevant declared interests, category of governor and the Board responsible for appointing us will be published on the school's website.
- In the interests of transparency, I accept that information relating to governors will be collected and logged on the DfE's national database of governors.
- I accept that governor information will be shared with the Local Authority and the Diocese to fulfil the statutory obligation to maintain a database of governors and kept in accordance with the General Data Protection Regulation.
- I accept that the Board purchases governance advice and a support package/training from SSE-Governance Services. Governor information will be shared with them and kept in accordance with the General Data Protection Regulations.

Relationships

- I will work as a part of a team in which constructive working relationships are actively promoted.
- I will express views openly, courteously and respectfully in communications with other governors, the Clerk to the Governing Board, and school staff both in and outside of meetings.
- I will support the Chair in their role of ensuring appropriate conduct both at meetings and at all times.
- I will be prepared to answer queries from other governors in relation to delegated functions and take into account any concerns expressed, and will acknowledge the time, effort and skills that have been committed to the delegated function by those involved.
- I will seek to develop effective working relationships with the Headteacher, staff and parents, the Diocese, Local Authority, other relevant agencies and the community.
- I respect the relationship and history between the church and the school and will promote and adhere to the Christian vision and values of the school.

Confidentiality

- I will observe complete confidentiality when matters are deemed confidential or where they concern specific members of staff or pupils, both inside or outside school.
- I will exercise the greatest prudence at all times when discussions regarding school business arise outside a Governing Board meeting.
- I will not reveal the details of any Governing Board vote.
- I will ensure all confidential papers are held and disposed of appropriately in line with expectations within the General Data Protection Regulation, including information held electronically.
- I will manage any information held on personal electronic devices such as laptops and mobile phones in line within expectations of the General Data Protection Regulation and the school Acceptable Use Policy.
- I will ensure that all Governor business is conducted via the @stjohnsprimary.uk email address provided and not my personal email account.

Conflicts of interest

- I will record any declared interest (including those related to people we are connected with) that I have in connection with the Governing Board's business in the Register of Business Interests, and if any such conflicted matter arises in a meeting I will offer to leave the meeting for the appropriate length of time.
- I accept that the Register of Business Interests will be published on the school website.
- I will declare any conflict at the start of any meeting should the situation arise.
- I will act in the best interests of the school as a whole and not as a representative of any group, even if elected to the Governing Board.

Ceasing to be a Governor

- I understand that the requirements relating to confidentiality will continue to apply after a governor leaves office, will return any papers to the Clerk and delete any electronic files.
- I understand that any school based email account will be closed and agree to delete any folders on any personal electronic devices.
- Should the Governing Board need to remove a governor from serving on the Governing Board and I am aware that the governor concerned also serves on another board, then I will inform the board concerned that the governor has been removed.
- If a governor is disqualified from continuing to serve and has informed the Clerk accordingly and I am aware that they serve on another board, I will check with that Clerk that the governor concerned has also informed them.

Breach of this code of conduct

- If I believe this code has been breached, I will raise this issue with the Chair and who will investigate. The Governing Board will only use suspension/removal as a last resort after seeking to resolve any difficulties or disputes in more constructive ways.
- Should it be the Chair that I believe has breached this code, another board member, such as the Vice Chair will be asked to investigate.

The Seven Principles of Public Life

Selflessness - Holders of public office should act solely in terms of the public interest. They should not do so in order to gain financial or other material benefits for themselves, their family, or their friends.

Integrity - Holders of public office should not place themselves under any financial or other obligation to outside individuals or organisations that might seek to influence them in the performance of their official duties.

Objectivity - In carrying out public business, including making public appointments, awarding contracts, or recommending individuals for rewards and benefits, holders of public office should make choices on merit.

Accountability - Holders of public office are accountable for their decisions and actions to the public and must submit themselves to whatever scrutiny is appropriate to their office.

Openness - Holders of public office should be as open as possible about all the decisions and actions that they take. They should give reasons for their decisions and restrict

information only when the wider public interest clearly demands.

Honesty - Holders of public office have a duty to declare any private interests relating to their public duties and to take steps to resolve any conflicts arising in a way that protects the public interest.

Leadership - Holders of public office should promote and support these principles by leadership and example.
